The wife of GGRCC founder Charles B. Schweizer, she died Oct.21, 2012, at age 96. They were married in Webster Groves, MO in 1941 when he was a lieutenant in the U.S. Army Corps of Engineers.

During the past two years we have seen a substantial increase in membership of GGRCC. There are now 96 members in the chapter. Unfortunately we have lost several members in the past two years: Ed Gerling, Richard Greene, Earl Gruber, Jim Kessler Jr., Ronald F. Luebben and Harry "Donald" Laughlin. Honorary member James Paulk died in February 2011 prior to NSSAR approval. The SAR ritual was conducted for GGRCC long-time member Clarence Iberg and for Richard Greene and Ed Gerling by request of families. Sadly, we also said goodbye to Mrs. Eleanor Schweizer, wife of GGRCC founder and first president Charles Schweizer. Please join me in a moment of silence for our dear departed compatriots.

There have been some additional activities added to our already busy schedule. The Wreaths Across America program has been well received and will be expanded this year to include the 39 veterans buried at Oak Lawn Cemetery located near Glen Carbon. Our Historic Flag Presentation has now expanded to 17 flags. Many people have enjoyed seeing the flags flying on June 14, Flag Day in the different communities in Madison County, especially last year at the Lewis and Clark Observation Towers in Hartford.

Another request that has increased is for participation by our color guard. We now have 12 members who have uniforms and take part when a color guard is requested. Our expanded involvement in the Boy Scout Eagle rank, Court of Honor ceremonies has created numerous invites for color guard members to attend. The pre-Memorial Day and Veterans Day parades have been an opportunity for our color guard members to become visible to the host communities--also at ROTC and AF-JROTC awards events. Several DAR activity leaders have requested our color guard to participate at their events. When we participate in the activities many people, particularly the children, want pictures taken with members of the color guard.

Our monthly luncheons have been well attended, most recently for the delicious meal and a chance to win the fifty-fifty raffle. Twice the Edwardsville/Glen Carbon Little League Association team sponsored by GGRCC finished in first place. We presented hero medals to Austin Roberts and Andrew Goekin. Law Enforcement Awards were presented to Chief Circuit Judge Ann Callis and Circuit Judge Charles Romani for the veterans court endeavor they have led. A Good Citizenship award was presented to 8-year-old Wyatt Erber. In addition, numerous Outstanding Citizenship Awards were presented to high school students from the surrounding communities. GGRCC yearly presents Flag Display Award certificates to residents of Madison County who fly the Flag daily--12 in 2012.
